- 11. No motor vehicle shall be operated within the flea market area in any manner that is deemed dangerous or places anyone in fear of contact with the vehicle or of mud or thrown debris.
- 12. AACA reserves the right to enforce, as noted below, any failure to pay damages caused to a flea market space or related physical grounds, or to equipment used or maintained by AACA or the owner of the premises where the meet is being held.

D. ENFORCEMENT

- Failure to abide by civil or AACA regulations will result in immediate expulsion and possible withdrawal from future flea market privileges and AACA membership.
- 2. Decisions by the Fall Meet Chairman or, if unavailable, Assistant Fall Meet Chairperson shall be final on all matters.
- No refunds of space leasing prices will be made in the event of expulsion.
- Any expenses involved in removing equipment or merchandise from the flea market area must be borne by the person or persons being expelled.

Flea Market Regulations

All vendors must be members of AACA. Each vendor will have a windshield sticker issued for each space and must have the sticker completely affixed to the outside of their vehicle windshield at time of entry onto the flea market field.

A. MERCHANDISE AND SERVICES ALLOWABLE FOR SALE

1. Only production motor vehicles 25-years-old or older and vehicles included in the vehicle classification schedule recognized by AACA for class judging, and parts, accessories, and certain automotive related items may be sold at National AACA Flea Markets. AACA and host organization reserve the sole right to sell officially-sanctioned AACA souvenirs, club merchandise, event memorabilia, or other items. The AACA specifically restricts the use of the AACA name and logo or any form thereof without prior approval of the Board of Directors; therefore, any unauthorized use of the AACA name and logo, in any form, is prohibited.

B. MERCHANDISE AND SERVICES PROHIBITED FROM SALE, SWAP, OR DISPLAY

- Motor vehicles newer than 25-years-old that are not included in AACA's Official Vehicles Classification Schedule.
- Parts, accessories and other automotive related items newer than 25-years-old.
- 3. Vehicles which are scaled down imitations of otherwise permissible vehicles capable of operation and occupancy by an adult or child and commonly referred to as "replicars."
- Full scale reproductions of permissible vehicles unless all major components are of authentic design and material.
- 5. All items, regardless of age, not related to vehicles 25-years-old or older including, but not limited to, farm machinery, signs, advertising material, tools and equipment, or literature and souvenirs unless produced by or for AACA or its regions and/or chapters.
- 6. Household or craft items of any age such as: furniture, rugs, clocks, pictures, china, bottles, jars, ashtrays, glassware, musical instruments, radios, telephones, lighting fixtures, etc.
- 7. Jewelry, clothing (except items 25-years-old or older and do not fall within the permissable category "Vintage or Reproduction of Vintage Fashion" as defined above.), watches, rings, beads, belt buckles, patches, T-shirts, etc.
- 8. New or used models, toys or kits of motor vehicles newer than 10-years-old.
- All cycles (bicycles, tricycles, quadricycles) newer than 25-years-old
 and self-propelled, excluding unattached bicycle motor wheels and
 buckboards less motor, but designed to be used with a motor either
 with or without human propulsion.
- 10. Aircraft, marine, railroad, horse drawn or off-the-road vehicles (except automotive racing cars), parts, models and related items.
- 11. Tools, hardware, shop service, shop equipment and service literature that is readily available on the open market.
- 12. All food and beverages except those sold by permission of the chaiman of the meet, the chairman of the flea market, or the owner of the premises where the meet is being held, which-ever the case may be.
- 13. Rosters or directories of the meet and/or flea market except by permission of the meet chairman.
- 14. All gambling devices, music juke boxes, vending machines, video games and fireworks of any kind.
- 15. **NO WEAPONS OF ANY KIND,** including guns, knives and ammunition are to be sold anywhere at the Fall Meet.

16. All Political Materials to include political merchandise (buttons, t-shirts, bumper stickers, posters, etc.) from past, present or future campaigns and literature (brochures, flyers, leaflets, etc. that promotes a specific political, legislative, or religious agenda.

C. GENERAL REQUIREMENTS AND CONDITIONS

- 1. National Meets are open to the general public. Therefore their operation and conduct gives the public an impression of us as a Club. Hershey Region, therefore, reserves the right to expel, after suitable warning, any persons including vendors who conduct themselves in a way that would reflect unfavorably upon AACA. Alcoholic beverage consumption on the premises is prohibited. It will be expected that all persons will be guided accordingly and under no circumstances indulge in objectionable conduct.
- 2. For the safety of our visitors and members, no moving vehicles (including motorbikes, scooters, roller blades, segways, skate boards, mini-bikes, motorcycles, two- or three-wheeled bicycles and private motorized carts) will be permitted to operate in the Flea Market or Meet area, except properly marked official vehicles, emergency vehicles responding to call, and those expressly permitted in writing by the chairman of the meet, chairman of the flea market, or owner of the premises where the meet is being held, whichever the case may be. Individual vehicles equipped for, operated by or transporting handicapped individuals may be permitted, with prior approval of Hershey Region, on an individual basis.
- 3. The hours during which the flea market at the National Meet is in operation will be from 7:00 A.M. to 5:00 P.M.
- 4. Flea market spaces are approximately 10 ft. x 30 ft. All equipment and wares must be within flea market space. No tent stakes are allowed on the blacktop flea market spaces. All tents must be secured by appropriate weights and sandbags. No cars or trailers are allowed to be parked in flea market streets. No flea market spaces shall be used solely for camping or parking. RESELLING OF SPACES IS PROHIBITED!
- 5. Pets must be leashed at all times and their waste picked up immediately. Barking/whining dogs are a nuisance to everyone and will not be tolerated. Vicious and threatening dogs are not permitted on the grounds. Vendor's dogs and cats are to be secured on the spaces assigned.
- 6. Generators causing excessive noise and fumes are prohibited. Generators shall be vented above vehicles and crowd. No running of generators from 11 p.m. to 6 a.m.
- 7. Septic service will be available on vendor fields only. Vendors should call Walters Septic Service at 1–800–690–5756. Fee charged. Anyone caught emptying on the field will be banned from all future AACA Eastern Division Fall Meets.
- 8. No windshield sticker shall be reproduced in any manner. Registered vendors of parking passes are responsible for their use and/or misuse regardless of the circumstances. If a windshield sticker is lost or damaged, it is to be reported immediately to security, or you will be held responsible for its later use. The windshield sticker must be applied to the vehicle in the upper corner of the windshield on the driver's side, in order to gain entry to the flea market (must be totally affixed).
- 9. Registered holders of parking passes and vendors are responsible for litter within their flea market spaces and are to remove the same daily and place it in designated containers.
- 10. There shall be no excessive and loud noise permitted between the hours of 11 p.m. and 6 a.m.
