CAR CORRAL NEWS

Car Corral Pre-Registration: You must pre-register for the same spaces that you had in 2023. If you would like to be relocated, please send your request along with your pre-registration and every effort will be made to honor your request. Additional spaces may be available during summer registration. Please remember to include your email address on the pre-registration card and read the regulations on the reverse side. **NOTE: Do NOT combine Car Corral pre-registration fee with Flea Market fee. YOU WILL NEED TO WRITE A SEPARATE CHECK IN THE EVENT YOU ARE ALSO PRE-REGISTERING FOR A FLEA MARKET SPACE(S).**

EVERY ATTEMPT WILL BE MADE TO ACCOMMODATE YOUR SPACE REQUESTS AND CHANGES. HERSHEY REGION CANNOT GUARANTEE YOUR REQUESTS.

The re-selling or subletting of Car Corral spaces is prohibited. You may request to transfer your space(s) to another AACA member in good standing by submitting a NOTARIZED letter to Hershey Region AACA, P.O. Box 305, Hershey, PA 17033 which includes the members name, space numbers, address and telephone number and AACA membership number. Unpaid spaces cannot be transferred.

No additional spaces (above what is listed on your address label) are sold during pre-registration. No Refunds. For additional spaces refer to the 2024 May/June issue of *The Antique Automobile* magazine that you receive every 2 months as an AACA member.

Car Corral spaces will be on the paved area around the Giant Center.

All vehicles must be driven into the Car Corral (*cannot be towed or pushed*). Unlicensed vehicles, unloaded behind the Giant Center, including transporter vehicles, must have a driver for each vehicle. **NO VEHICLES ON TRAILERS ADMITTED INTO THE CAR CORRAL.** Transporters must be removed as soon as vehicles are unloaded.

Stickers must be completely adhered to the upper left corner of windshield (driver's side), and in the manner for which the sticker is designed. Tape, grease, or any other means of sticker attachment will be grounds to refuse admittance. Vendors with improperly applied stickers that need to be replaced will incur a \$25.00 replacement fee. Stickers need to be replaced immediately or your vehicle will be towed at your expense. Towing/storage fees will be the responsibility of the vehicle owner.

One vehicle per space (including motorcycles).

Space is limited so please be cautious when moving vehicles. Keep traffic lanes open and refrain from driving as much as possible. Excessive speed, horseplay, or any activity deemed unsafe will be immediate grounds for removal from car corral.

The Car Corral regulations will again be strictly enforced in 2024!
(See enclosed regulations.)

- All vehicles **MUST** be in **TOTAL COMPLIANCE** with an AACA Official Classification....1999 or earlier.
- No street rods, modified/custom or replicars. If you are in violation your vehicle will not be allowed entrance to the Car Corral.
- AACA 2024 membership is required for pre-registration renewal. (Call AACA National Headquarters at 717-534-1910). If you haven't received your membership card by January 15th, you should submit your pre-registration card with a note stating such and write your 2023 AACA number in the space provided for your card copy.
