HR's Back Lot Regulations

1. **No Refunds.**
2. Returned checks will be charged a \$35 administration fee.
3. Only One (1) vehicle per space including motorcycles.
4. All transactions are between buyer and seller.
5. Cars, Trucks, Motorcycles, Street rods, modified/custom, kit cars, and replica cars are welcome in **HR's Back Lot** and are to be parked in the **HR's Back Lot** section. Hershey Region Staff will direct.
6. Vehicles must be 25 years old or older, (1998 model year), and driven into the Back Lot under their own power. No vehicles on trailers, pushed, towed, or flea market items.
7. Vehicles on trailers will be off-loaded in back of the Giant Center. Empty trailers will be taken to "The Orchard". Hershey Region staff will direct.
8. All Vehicles must be PARKED ONLY WITHIN THE CONFINES OF SPACE ASSIGNED TO THE VENDOR. NO ANGULAR PARKING.
9. No Back Lot traffic from 5:00 a.m.-11:00 a.m. on Friday. We prefer that you do not remove your cars on Thursday evening due to not being permitted to re-enter prior to 11:00 a.m. on Friday.
10. All vehicles must be removed by Friday 1:00 PM Oct. 11, 2024, OR WILL BE TOWED AT OWNER'S EXPENSE.
11. Entry Stickers will be returned by mail after Aug. 26, 2024. Place stickers per instructions. Stickers will match numbers on pavement indicating parking location. Every spot will be marked on pavement. \$25 fee for replacing stickers not attached properly and needing to be replaced.
12. No tents, canopies, beach / patio umbrellas, private portable toilets, self-standing signage allowed in any areas of the Back Lot.
13. Reselling of all spaces must be arranged by Hershey Region staff.
14. Hershey Region or the owners of the land are not responsible for damaged or stolen vehicles or any part thereof.
15. On-site Registration begins Tuesday Oct. 8, 2024 @ 11:00am.
16. Participants must adhere to all rules.
17. Final decisions are made by the Fall Meet Chairman.
